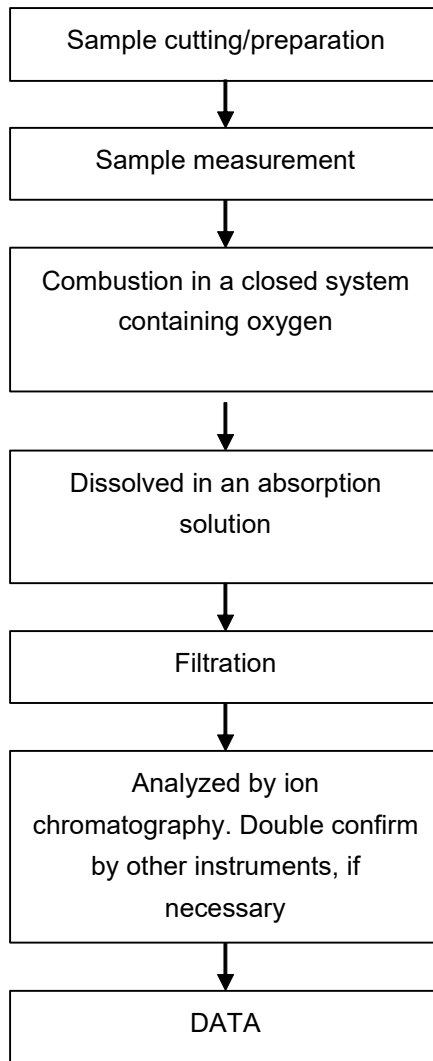

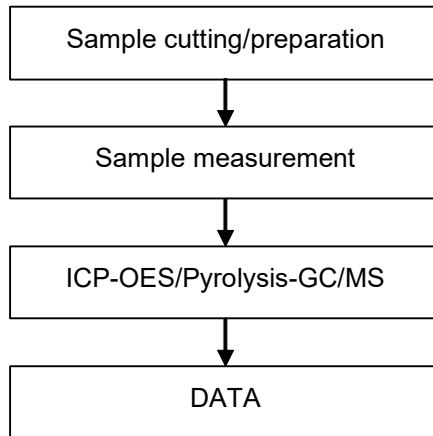

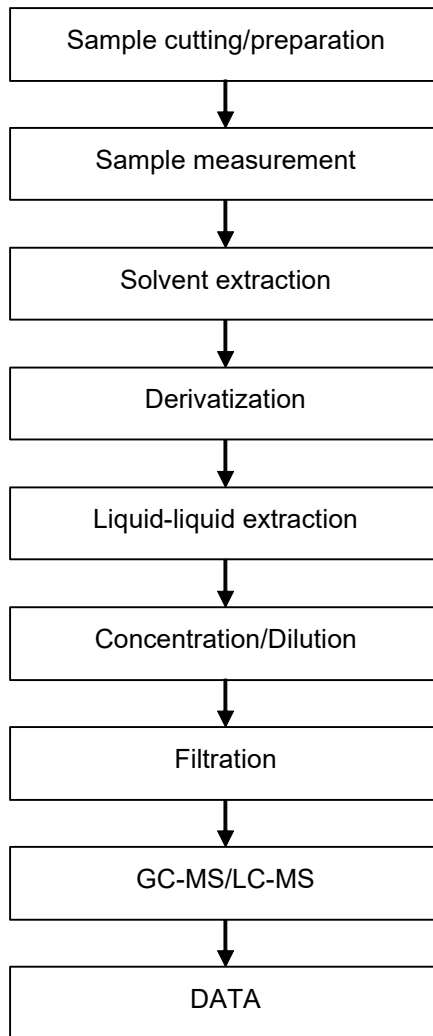

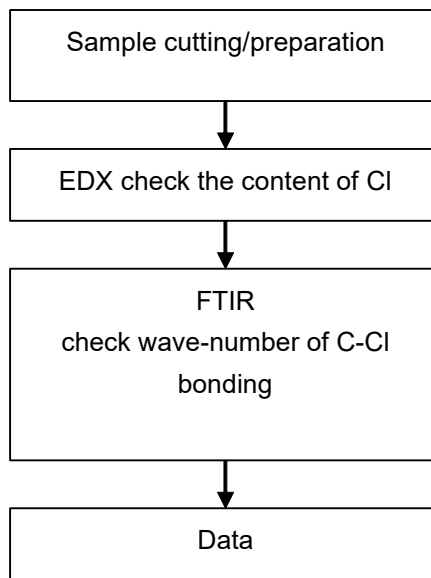

PVC Testing Flow Chart

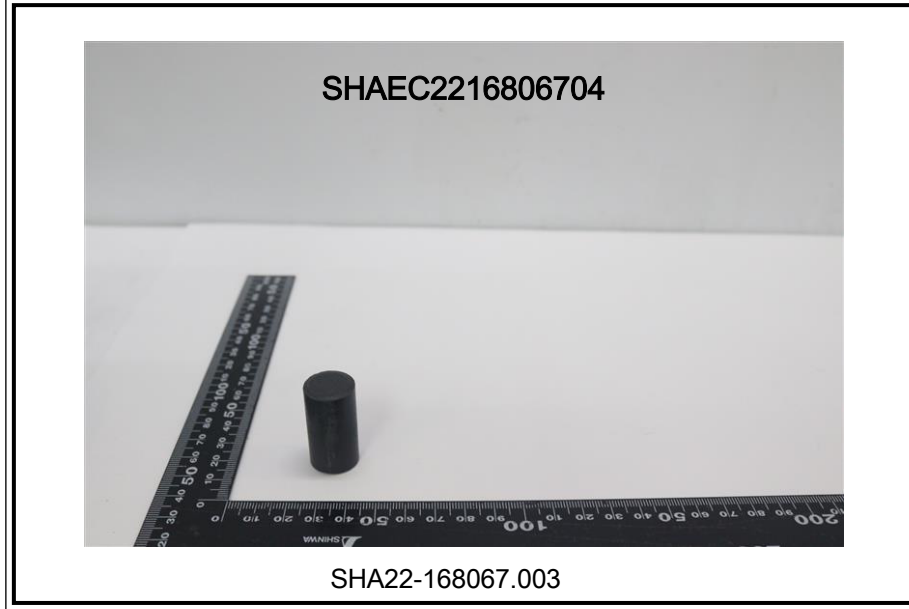
